(a) FINDINGS.—Congress finds the following:

1	(1) Established in 1963 and bestowed by the
2	President of the United States, the Presidential
3	Medal of Freedom is the highest civilian honor of
4	our Nation.
5	(2) The Presidential Medal of Freedom is
6	awarded to recipients for "especially meritorious
7	contributions to the security or national interests of
8	the United States, to world peace, or to cultural or
9	other significant public or private endeavors".
10	(3) William Henry "Bill" Cosby, Jr. (in this
11	subsection referred to as "Cosby") received the
12	Presidential Medal of Freedom in 2002.
13	(4) In recent months, more than 50 women
14	have come forward and conveyed disturbing accounts
15	of sexual assault and drugging by Cosby.
16	(5) The statute of limitations has expired for
17	many of these incidents, and as a result, the major-
18	ity of these women will never get their day in court.
19	(6) According to the New York Daily News,
20	court documents obtained by the Associated Press
21	on Monday, July 7, 2015, revealed that "Cosby ad-
22	mitted under oath that he bought Quaaludes to dope
23	the women he wanted to grope—and slipped the sed-
24	ative to at least one lady and 'other people'".

1	(7) During a deposition on September 29
2	2005, a lawyer, Dolores Troiani, asked Cosby
3	"When you got the Quaaludes, was it in your mind
4	that you were going to use these Quaaludes for
5	young women that you wanted to have sex with?'
6	and Cosby answered "Yes."
7	(8) On December 30, 2015, prosecutors from
8	Montgomery County, Pennsylvania, charged Cosby
9	with three counts of felony aggravated indecent as-
10	sault for allegedly drugging and sexually assaulting
11	a young woman in 2004.
12	(9) The prosecutors noted in an affidavit of
13	probable cause that "Cosby obtained seven separate
14	prescriptions for Quaaludes that he did not person-
15	ally ingest, nor ever intended to personally ingest'
16	and that "the victim's substantially impaired condi-
17	tion prevented her ability to consent, or even defend
18	herself from Cosby's sexual assault".
19	(10) Cosby has admitted to drugging women in
20	order to satisfy his sexual desires, and, therefore
21	the Federal Government should not recognize Cosby
22	with an honor like the Presidential Medal of Free-
23	dom.
24	(b) Sense of Congress.—It is the sense of Con-
25	gress that the President should revoke the Presidential

- 10 "Whoever, with the intent to defraud any person,
- 11 wears or publicly displays a Presidential Medal of Free-
- 12 dom that has been declared to be revoked by the President
- 13 shall be fined under this title or imprisoned for not more
- 14 than one year, or both.".
- 15 (b) CLERICAL AMENDMENT.—The table of sections
