Need another reason to secure the border? Illegal immigration and drug smuggling is bad for the environment. The Tucson Border Patrol reports that the average illegal border crosser leaves an average of 8 pounds of garbage on our land and in our forests. That's nearly 60 million pounds of trash every year. I saw a bunch of this litter firsthand during my border tour.


