I visited two separate cancer treatment facilities in Casa Grande where I spoke with doctors and administrators about the future of medical services in the U.S. and highlighted my plan, H.R. 1150, the "Competitive Health Insurance Reform Act of 2011," which will increase competition among insurance providers and decrease the overall cost of healthcare.

I also met with the stakeholders of the Lower Santa Cruz River Alliance, an organization in Pinal County working with the U.S. Army Corps of Engineers (USACE) on prioritizing a project that will protect the lives and property of the residents of Pinal County from dangerous and catastrophic flooding that could do considerable damage to the second fastest-growing county in the country. I, Congressman Grijalva, and Arizona Governor Jan Brewer have all expressed public support to the USACE for this very important, bi-partisan project.

I was also able to attend a "Hiring Our Heroes" Job Fair that took place in Phoenix. Sponsored by the U.S. Chamber of Commerce and many other local groups, the event focused on bringing businesses and military veterans together to get our unemployed, returning servicemen and women back to work stateside. I was joined by Arizona Congressmen Trent Franks (R-AZ-02) and David Schweikert (R-AZ-05) at the event. About 100 companies were present and nearly 1,000 veteran job-seekers were in attendance.

I am honored to serve as your Member of Congress. By listening to your concerns and talking about common sense solutions, together we can make Arizona's First Congressional District a thriving community and great place to work and live. I encourage you to contact me about issues that are important to you, and I hope to meet you in person during my future travels throughout our district.
