## Spring in Full Swing

Dear Friend,

It has been a busy two weeks in Washington, D.C. This spring the House of Representatives is in full swing as I have passed legislation to protect Coconino County homeowners' property rights. I also voted for legislation to protect recreational outdoor activities. I would like to keep you up-to-date with the latest from the House of Representatives, as well as inform you of upcoming events in Arizona.

### Arizona Must Do What the Federal Government Refuses to Do

I feel strongly that the Obama Administration erred in its decision to sue the state to block important provisions of this law. I am confident that the U.S. Supreme Court will uphold Arizona's rights to protect its citizens and law enforcement officers. See my full statement on *Arizona v. United States* [here](#).

Recent [national opinion-polling](#) shows that Americans are increasingly supportive of this piece of legislation, favoring S.B. 1070 by a 65-31 margin.

### **Gosar Legislation to Protect Property Rights Passes U.S. House**

My legislation, the Mountaineer Relief Bill (H.R. 1038), passed the U.S. House of Representatives by a vote of 421 to 1. This is the third bill that I have had pass through the House in my first term. The legislation settles a federal land boundary dispute in the Mountaineer Subdivision of Coconino County, Arizona. I am so proud of the folks in Coconino whose teamwork helped me bring this situation to light, and helped me get it to the House floor. You can see more [here](#).

### **Congressman Gosar Votes for the Sportsmen Heritage Act of 2012**

As an avid outdoorsman, I have always believed that we should be able to hunt, fish, and respectfully enjoy the wilderness of Arizona without the federal government's regulations and restrictions telling us how to do so. That is why I voted for the Sportsmen Heritage Act of 2012 (H.R. 4089) to stop unwarranted federal regulations against those of us who enjoy the great outdoors.
