As many of you already know, this past week the House held elections to replace John Boehner as Speaker of the House after he resigned his position. We had hundreds of Arizonans call in to my office to voice their thoughts and opinions about who our next Speaker should be. I listened very carefully to what these callers had to say because ultimately, it was your actions and votes that gave Republicans historic majorities in the House and Senate. My focus for the new House leadership has always been on fixing our broken legislative process. The voice of the American people is silenced when power is consolidated at the top amongst a handful of members. Our next Speaker must return the House to regular order and allow for a transparent system that incorporates all members of Congress in important decisions. This past week, I joined 18 of my House colleagues to introduce articles of impeachment for IRS Commissioner John Koskinen. Under his direction, IRS officials have led a coordinated effort to hide the truth about this rogue agency's targeting of innocent Americans based on their political beliefs. On Koskinen's watch, the IRS intentionally destroyed nearly 24,000 emails from Lois Lerner and failed to comply with a Congressional subpoena. To make matters worse, Commissioner Koskinen made a series of false and misleading statements, under oath, to Congress at multiple committee hearings on this matter. Koskinen said in March 2014 that the IRS had turned over all Lerner's emails and all requested information, yet, the Treasury Inspector General for Tax Administration uncovered more than 1,000 emails that the IRS tried to hide. As a result of this despicable conduct and his fraudulent statements under oath, Koskinen is guilty of high crimes and misdemeanors and must be impeached.

Commissioner Koskinen's crimes are a scar on our Republic and an affront to the first amendment protections of our Constitution.
