The federal government continues to spend recklessly, and to destroy America's responsibility to leave younger generations with the prospect of a better tomorrow.
















We have nearly "\$51,000 in debt for every man, every woman, and every child in America."

## Letting the EPA Know We Do Not Need Higher Energy Prices

The president continues to claim to support an "all of the above" approach to meeting our nation's energy needs, yet his administration is waging a war on coal.

Yesterday, in response to the EPA's refusal to do so, I hosted a public hearing for residents of St. Johns to discuss the Environmental Protection Agency's proposed jobkilling regulations on the Coronado Generating Station.

These regulations from the EPA would increase energy prices for local businesses and residents, and will cost jobs in the region. Many residents filed written statements to let the EPA know that the red-tape needs to go.

## **Demanding Answers on Operation Fast and Furious**

On Tuesday, September 11th the Committee on Oversight and Government Reform and I will be questioning Department of Justice Inspector General Michael Horowitz on his investigation into Operation Fast and Furious.



In June, Attorney General Eric Holder was found by the House of Representatives to be in contempt of Congress.

Just like President Nixon could not use executive privilege to cover up the commission of a crime by himself or others, it is not going to fly with this president's actions in Operation Fast and Furious either.
