Today marks the two year anniversary since the death of Border Patrol Agent Brian Terry. Our nation lost one of our own who was protecting us by securing the Arizona/Mexico border. Border Patrol Agents William Castano, Gabriel Fragoza and Timothy Keller were also on patrol with Agent Terry on the night he was killed—their bravery and loyalty should never be forgotten.

After the dust settled that horrific night, details were brought to light about our government’s role in supplying weapons found at the scene of the crime. I ask that you please join me in keeping Agent Terry and his family in your thoughts and prayers.

### Fast and Furious Update

This week, a federal judge sentenced Jaime Avila Jr. for buying arms for a Mexican drug cartel, two of which were found at the scene of Agent Terry's death. He was sentenced to nearly five years in federal prison. [Please read more here.](#)
