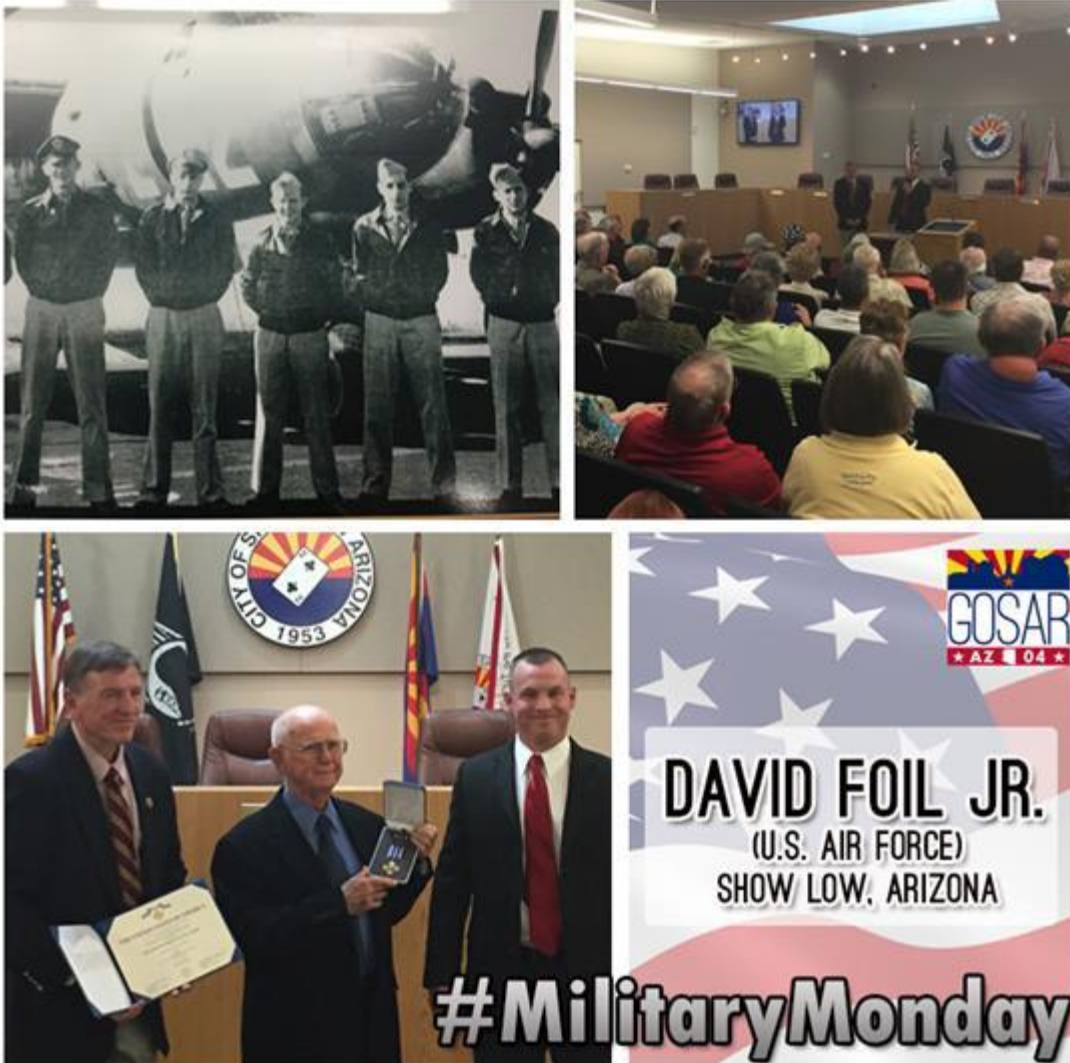
Eagle Motorcycle Rentals opens its doors in Bullhead City

Military Monday



This week's [Military Monday](#) is very timely because it features David Foil Jr. of Show Low, Arizona, who I had the honor of presenting the Distinguished Flying Cross medal this past Monday.

David's story was featured in a recent article by Jo Baeza in the White Mountain Independent. Copied below are some of the highlights:

"Most Americans today experience World War II in black and white. They watch documentaries or dramas "based on fact." They can forget about the war when they turn off the TV or walk out of a movie theater. For those who served in the military or lost loved ones, World War II is not that easily forgotten.

David A. Foil Jr., the flight engineer-gunner for a Martin B-26 Marauder crew, was stationed north of London with the 450th Bomb Squadron, 322 Bomb Group, of the U.S. Ninth Air Force. In recalling those days, he wrote: "We entered combat soon after the D-Day landings in France. Our first four missions were flown from England. Flying the English Channel each way was a hazard that we did not like, so we were pleased to be moved to an ex-German airfield about 50 miles north of Paris at Beauvais, France. It was at this base that we spent the fall and winter of 1944 and spring of 1945. In early spring we moved from France to an airfield near Louvain in Belgium. Our final few missions were flown from Belgium before the war in Europe ended [May 8, 1945]. In total

I flew 43 combat missions over Germany.

Seventy years later, the U.S. Air Force informed Foil that he had been awarded the Distinguished Flying Cross for service in World War II. The medal is awarded for 'heroism or extraordinary achievement while participating in an aerial flight.' In Europe some of the bomber crews that survived their wing or group sorties received DFCs for completing a tour of duty of 25 sorties. David flew 43 sorties over Germany 1944-45."
