Putting a Stop to Obama's "Assault on the Suburbs"



This week's Military Monday honors Harry Oberg of Prescott, Arizona. Harry served as an Army helicopter pilot during his two tours to Vietnam.



Harry has lived in Prescott since he was two-years old and upon graduating from Arizona State College, he was drafted on November 6, 1966. Harry's first command assignment was in Germany in 1972 as the Headquarters and Troop Commander in charge of roughly 400 soldiers. These brave soldiers were providing staff support to combat line units of the reconnaissance squadron that belonged to a cavalry regiment near the East German border.
