November Legislative Updates



Putting the Brakes on the U.S. Refugee Resettlement Program

I'm proud of Arizona Governor Doug Ducey and support his decision to join many other Governors in immediately halting further entry into Arizona of any new refugees from Middle Eastern countries. The Obama Administration has not proven that it can effectively screen these people to ensure they don't have terrorist connections. Top national security officials, including FBI Director Comey, have repeatedly warned that the U.S. government does not have the resources and dramatically lacks the information needed to fully vet refugees from Syria. No amount of self-righteousness by President Obama can change the fact that advocating for the transfer of more Syrian refugees to the U.S. jeopardizes American security. The president's actions are not patriotic or compassionate; they are reckless and short-sighted.

My colleagues and I are trying to stop these transfers in Congress and I am proud to be a cosponsor of H.R. 3314, introduced by my good friend and colleague Rep. Brian Babin (R-TX). If enacted, this bill will put an immediate moratorium on the refugee resettlement program and prevent these potentially dangerous individuals from entering our borders. We must always remember that the primary duty of the federal government is to protect Americans from harm. Admitting Syrian refugees unnecessarily places national security and American lives at risk.

Arizona Leads the Way in Fighting Back Against the EPA's New Ozone Rule

Arizona is on the front lines of fighting back against the EPA's dangerous new ozone rule. Senator Jeff Flake and I have introduced companion legislation to ensure that the president's extremist environmental agenda never sees the light of day. If the president believes so strongly that his \$25 billion/year ozone regulation is what's best for America, why would he need to circumvent Congress and the American people to implement it? This flurry of new environmental regulations has nothing to do with protecting our environment but rather is about gaining more control over the lives of hard-working Americans.



Regardless of President Obama's resentment of the legislative process, our system of checks and balances is more powerful than his desire to force his will on the American people. The U.S. economy can't afford a nearly \$2 trillion hit to our GDP and the loss of millions of jobs as a result of an unnecessary and overreaching new regulation not based on science. It is far past time that Congress reined in the rogue actions of the EPA. I support continuing commonsense and voluntary efforts to reduce ozone levels, not unachievable mandates that will kill jobs and drive up energy prices for consumers.

Arizona Supreme Court Upholds State Water Rights, Affirms Gosar Legislation

Earlier this month, the Arizona Supreme Court unanimously ruled in favor of the Arizona Department of Water Resources (ADWR) and upheld the agreements codified by my legislation, H.R. 4924, the Bill Williams Water Rights Settlement Act, paving the way for the settlement of certain claims within the Bill Williams River Watershed among the Hualapai Tribe,

the United States, the Arizona Game and Fish Commission and Freeport-McMoRan.

The opinion by the Arizona Supreme Court upholds state water rights and affirms ADWR's critical role in protecting these rights. I'm disappointed that the plaintiffs in the original case asserted a number of baseless claims at taxpayer expense in seeking to prevent a private water rights settlement which has significant benefits for local waters users and the State of Arizona. This unnecessary legal challenge could have easily been avoided but unfortunately the Mohave County Supervisors have potentially put Arizona taxpayers on the hook for even more fees resulting from this frivolous lawsuit.

Moving forward, I believe this case can serve as a teachable moment for Arizona's citizens, water users and Supervisors throughout the state. Rather than trying to upend a water rights settlement paid for with private money and involving private property, we should all work together and encourage commonsense solutions that benefit all parties.
