Also this week, I spoke in Prescott. With nearly 400 people in attendance, it was an exciting event to talk about the realities of our economic situation and how the explosive growth of the federal government threatens our liberties. The sluggish economic recovery and the IRS' discriminatory practices are perfect examples of these problems.

The first solution to these problems is relatively simple: rein in the size and scope of the federal government and let the private sector work. Entrepreneurs, unburdened by bureaucratic red tape, are the engine of the economy, not more government spending. A limited government is also inherently restricted from abusive practices like we saw at the IRS.

## **Payson Tea Party Meeting**

On Thursday, I traveled to Payson and spoke with the local Tea Party group. I shared with them the work I am doing in Washington, D.C. to hold the IRS accountable and get to the bottom of their targeting of Tea Party and other conservative groups.

More specifically, I discussed the <u>IRS Anti-Abuse Act</u>, which I introduced along with fellow Arizona Congressmen Salmon and Schweikert. This legislation

makes it illegal to discriminate against organizations and individuals based on political affiliation and ideology. It also makes this sort of discrimination a fireable offense.

I always encourage everyone to share their ideas with me on how we can find solutions to the problems that face our country. Thank you to all of those in attendance for taking part in these discussions. I look forward to future events and working with additional groups.
