# RESOLUTION

Impeaching Regina McCarthy, Administrator of the United  
States Environmental Protection Agency, for high crimes  
and misdemeanors.

1       *Resolved*, That Regina McCarthy, Administrator of  
2 the Environmental Protection Agency, is impeached for  
3 high crimes and misdemeanors and that the following arti-  
4 cles of impeachment be exhibited to the Senate:

5       Articles of impeachment exhibited by the House of  
6 Representatives of the United States of America in the  
7 name of itself and of the people of the United States of  
8 America, against Regina McCarthy, Administrator of the

1 United States Environmental Protection Agency, in main-  
2 tenance and support of its impeachment against her for  
3 high crimes and misdemeanors.

4 **ARTICLE I.**

5 Regina McCarthy, while Administrator of the United  
6 States Environmental Protection Agency, committed per-  
7 jury before the Committee on Oversight and Government  
8 Reform of the House of Representatives on July 29, 2015  
9 in violation of section 1621 of title 18, United States  
10 Code.

11 Wherefore, Administrator Regina McCarthy, by such  
12 conduct, is guilty of high crimes and misdemeanors and  
13 should be removed from office and disqualified to hold and  
14 enjoy any office of honor, trust, or profit under the United  
15 States.

16 **ARTICLE II.**

17 Regina McCarthy, while Administrator of the United  
18 States Environmental Protection Agency, made false  
19 statements before the Committee on Science, Space, and  
20 Technology of the House of Representatives on July 9,  
21 2015 in violation of section 1001 of title 18, United States  
22 Code.

23 Wherefore, Administrator Regina McCarthy, by such  
24 conduct, is guilty of high crimes and misdemeanors and  
25 should be removed from office and disqualified to hold and

1 enjoy any office of honor, trust, or profit under the United  
2 States.

3 **ARTICLE III.**

4 Regina McCarthy, while Administrator of the United  
5 States Environmental Protection Agency, made false  
6 statements before the Committee on the Environment and  
7 Public Works of the United States Senate and the Com-  
8 mittee on Transportation and Infrastructure of the House  
9 of Representatives on February 4, 2015 in violation of sec-  
10 tion 1001 of title 18, United States Code.

11 Wherefore, Administrator Regina McCarthy, by such  
12 conduct, is guilty of high crimes and misdemeanors and  
13 should be removed from office and disqualified to hold and  
14 enjoy any office of honor, trust, or profit under the United  
15 States.
