

AMENDMENT TO RULES COMM. PRINT 117-40
OFFERED BY MR. GOODEN OF TEXAS

Add at the end the following:

1 **SEC. 14. PROHIBITED IDENTIFICATION DOCUMENTS AT**
2 **AIRPORT SECURITY CHECKPOINTS; COLLEC-**
3 **TION OF BIOMETRIC INFORMATION FROM**
4 **CERTAIN INDIVIDUALS SEEKING ENTRY INTO**
5 **THE STERILE AREA OF AN AIRPORT.**

6 (a) PROHIBITED IDENTIFICATION DOCUMENTS AT
7 AIRPORT SECURITY CHECKPOINTS.—

8 (1) IN GENERAL.—The Administrator may not
9 accept as valid proof of identification a prohibited
10 identification document at an airport security check-
11 point.

12 (2) NOTIFICATION TO IMMIGRATION AGEN-
13 CIES.—If an individual presents a prohibited identi-
14 fication document to an officer of the Transpor-
15 tation Security Administration at an airport security
16 checkpoint, the Administrator shall promptly notify
17 the Director of U.S. Immigration and Customs En-
18 forcement, the Director of U.S. Customs and Border
19 Protection, and the head of the appropriate local law
20 enforcement agency to determine whether the indi-

1 vidual is in violation of any term of release from the
2 custody of any such agency.

3 (3) ENTRY INTO STERILE AREAS.—

4 (A) IN GENERAL.—Except as provided in
5 subparagraph (B), if an individual is found to
6 be in violation of any term of release under
7 paragraph (2), the Administrator shall not per-
8 mit such individual to enter a sterile area.

9 (B) EXCEPTION.—An individual presenting
10 a prohibited identification document under this
11 section may enter a sterile area if the indi-
12 vidual—

13 (i) is leaving the United States for the
14 purposes of removal or deportation; or

15 (ii) presents a covered identification
16 document.

17 (b) COLLECTION OF BIOMETRIC INFORMATION FROM
18 CERTAIN INDIVIDUALS SEEKING ENTRY INTO THE STER-
19 ILE AREA OF AN AIRPORT.—

20 (1) IN GENERAL.—Beginning not later than
21 120 days after the date of the enactment of this Act,
22 the Administrator shall collect biometric information
23 from an individual described in paragraph (2) prior
24 to authorizing such individual to enter into a sterile
25 area.

1 (2) INDIVIDUAL DESCRIBED.—An individual de-
2 scribed in this paragraph is an individual who—

3 (A) is seeking entry into the sterile area of
4 an airport;

5 (B) does not present a covered identifica-
6 tion document; and

7 (C) the Administrator cannot verify is a
8 national of the United States.

9 (3) PARTICIPATION IN IDENT.—Beginning not
10 later than 120 days after the date of the enactment
11 of this Act, the Administrator, in coordination with
12 the Secretary of Homeland Security, shall submit bi-
13 ometric data collected under this section to the
14 Automated Biometric Identification System
15 (IDENT).

16 (c) DEFINITIONS.—In this section:

17 (1) BIOMETRIC INFORMATION.—The term “bio-
18 metric information” means any of the following:

19 (A) A fingerprint.

20 (B) A palm print.

21 (C) A photograph, including—

22 (i) a photograph of an individual’s
23 face for use with facial recognition tech-
24 nology; and

1 (ii) a photograph of any physical or
2 anatomical feature, such as a scar, skin
3 mark, or tattoo.

4 (D) A signature.

5 (E) A voice print.

6 (F) An iris image.

7 (2) COVERED IDENTIFICATION DOCUMENT.—

8 The term “covered identification document” means
9 any of the following, if the document is valid and
10 unexpired:

11 (A) A United States passport or passport
12 card.

13 (B) A biometrically secure card issued by
14 a trusted or registered traveler program of the
15 Department of Homeland Security, including—

16 (i) Global Entry;

17 (ii) NEXUS;

18 (iii) Secure Electronic Network for
19 Travelers Rapid Inspection (SENTRI);
20 and

21 (iv) Free and Secure Trade (FAST).

22 (C) An identification card issued by the
23 Department of Defense, including such a card
24 issued to a dependent.

1 (D) Any document required for admission
2 to the United States under section 211(a) of
3 the Immigration and Nationality Act (8 U.S.C.
4 1181(a)).

5 (E) An enhanced driver's license issued by
6 a State.

7 (F) A photo identification card issued by a
8 federally recognized Indian Tribe.

9 (G) A personal identity verification creden-
10 tial issued in accordance with Homeland Secu-
11 rity Presidential Directive 12.

12 (H) A driver's license issued by a province
13 of Canada.

14 (I) A Secure Certificate of Indian Status
15 issued by the Government of Canada.

16 (J) A Transportation Worker Identifica-
17 tion Credential.

18 (K) An Employment Authorization Docu-
19 ment issued by U.S. Citizenship and Immigra-
20 tion Services.

21 (L) A Merchant Mariner Credential issued
22 by the Coast Guard.

23 (M) A Veteran Health Identification Card
24 issued by the Department of Veterans Affairs.

1 (N) Any other document that the Adminis-
2 trator determines, pursuant to a rule making in
3 accordance with section 553 of title 5, United
4 States Code, will satisfy the identity verification
5 procedures of the Transportation Security Ad-
6 ministration.

7 (3) IMMIGRATION LAWS.—The term “immigra-
8 tion laws” has the meaning given that term in sec-
9 tion 101 of the Immigration and Nationality Act (8
10 U.S.C. 1101).

11 (4) PROHIBITED IDENTIFICATION DOCU-
12 MENT.—The term “prohibited identification docu-
13 ment” means any of the following (or any applicable
14 successor form):

15 (A) U.S. Immigration and Customs En-
16 forcement Form I-200, Warrant for Arrest of
17 Alien.

18 (B) U.S. Immigration and Customs En-
19 forcement Form I-205, Warrant of Removal/
20 Deportation.

21 (C) U.S. Immigration and Customs En-
22 forcement Form I-220A, Order of Release on
23 Recognizance.

24 (D) U.S. Immigration and Customs En-
25 forcement Form I-220B, Order of Supervision.

1 (E) Department of Homeland Security
2 Form I-862, Notice to Appear.

3 (F) U.S. Customs and Border Protection
4 Form I-94, Arrival/Departure Record (includ-
5 ing a print-out of an electronic record).

6 (G) Department of Homeland Security
7 Form I-385, Alien Booking Record.

8 (5) STERILE AREA.—The term “sterile area”
9 has the meaning given that term in section 1540.5
10 of title 49, Code of Federal Regulations, or any suc-
11 cessor regulation.
